Chair's Message - The Evolution of NUPIC

The members of NUPIC understand that we must be a "Learning Organization" and we are continuously looking for ways to become more efficient and cost effective while delivering the best product we possibly can. We've come a long way since those early days in 1989 when the organization was formed. In the past 28 years we have seen mergers and acquisitions, the nuclear renaissance, and external challenges to our industry. During those 28 years NUPIC has evolved with the changing times. In October 2017 NUPIC took another step in the evolution of the organization. On October 11, 2017 the NUPIC membership voted to become a corporation. The new name of the organization is "Nuclear Procurement Issues Corporation." NUPIC is now a non-profit corporation under the laws of the Commonwealth of Pennsylvania. This effort started 3 years ago under the Chairmanship of Stan Mitchell (Exelon) and was realized this past October under the Chairmanship of Brian Mervak (SCE&G). From the outside not much has changed. NUPIC will continue to operate in the same manner as before. However, instead of a Memorandum of Understanding and a Charter we now have the "Articles of Incorporation" and "Bylaws."

In the May 2017 Newsletter Brian Mervak discussed audit findings and deficiencies and how going forward audit teams will need to determine if an issue meets one of the new definitions. So far this has been an interesting exercise and implementation has not been as "black & white" as hoped and expected. During the October 2017 NUPIC Conference the NRC expressed some concern with how we are classifying some issues and warned us not to dilute our process by issuing deficiencies where a finding is more appropriate. As with any new process there is a learning curve and NUPIC has already planned additional training for our Lead Auditors for 2018 along with procedure changes so that we will be more consistent on how we apply these new definitions.

During the October NUPIC Conference one of the Key-Note speakers asked the audience how many in the room have been a NUPIC representative less than 3 years. I was stunned to see that over half in attendance raised their hands. NUPIC is a real-time example of the ongoing knowledge transfer in the nuclear power industry. Over the past few meetings we have seen so many of our experienced lead auditors retire and move to the lake or mountains for the next chapter in their lives. And from where I sit, I really believe NUPIC is blessed with some very talented fresh faces to continue moving this organization forward.

Finally, I can't end this article without giving a "shout-out" to Brian Mervak of SCE&G. Brian was the NUPIC Chairman for the past 2 years and we all want to thank him for his tireless dedication and leadership to our organization. Brian has chosen to retire and try something new, and the membership would like to wish him the "very best of luck."

One last thing, don't forget about the Joint EPRI-JUTG/NUPIC Conference to be held in Orlando, FL at the Sheraton Lake Buena Vista Resort January 29th through February 1, 2018. This will be the first time that the EPRI Joint Utility Task Group for Procurement Engineering and the NUPIC Lead Auditor Training will be held jointly. We are excited that these 2 groups are meeting and anticipate a lively interactive exchange of ideas. Look for the details on the EPRI and NUPIC websites. I hope to see you there!

NUCLEAR FUEL COMMITTEE OF NUPIC

This committee is one of the NUPIC Standing Committees, and its activities should be of great interest to every NUPIC Member. It would be hard to think of a purchased commodity other than nuclear fuel that has more direct economic, reliability, or safety impact. Three "Affinity Groups" (AG) comprise the Committee, representing utilities that purchase from Areva, Westinghouse, and GNF. The Nuclear Fuel Committee (NFC) Chairman is a member of the NUPIC General Membership and in that role oversees and coordinates activities of the AGs in order to maximize efficiency and effectiveness of fuel oversight activities while protecting proprietary information. Each AG similarly chooses a Chairman.

The Nuclear Fuel Committee meets annually during the NUPIC Fall Conference, most recently in Omaha Nebraska on October 9. At that meeting the committee considered new ways to strengthen the NUPIC Fuels Audits. This included enhanced use of the Shared AG Surveillances, and increased technical input. Better integration of the AG Surveillance and NUPIC Audit Process was determined to be a key towards improved fuel quality performance. The GNF AG Shared Surveillance Program was discussed as a model for the other AGs. Also, the NUPIC Website now includes a location for storing and downloading by members of these shared surveillances. NUPIC Members can access these surveillances by AG, by going to "Download Center / Nuclear Fuel Affinity Groups / (select fuel manufacturer)" on www.NUPIC.com.

At the NUPIC Membership Meeting that followed the October NFC Meeting, the Chairman reported out on current activities and upcoming changes to the industry as fuel manufacturers continue to evolve in design and diversity. He encouraged active participation by members in their respective Affinity Groups; most will be scheduling their Spring 2018 Annual Meetings to review new developments and plan upcoming shared surveillance opportunities.

The three Affinity Groups (Areva, GNF, and Westinghouse) comprise the NUPIC Nuclear Fuel Committee, currently chaired by EXL. Each Affinity Group holds an annual working meeting to organize shared resources for oversight efficiency and effectiveness. All three Affinity Groups meet jointly as the Nuclear Fuel Committee concurrent with the Fall NUPIC General Membership Meeting. By pooling resources and sharing fuel specific oversight information these groups help drive continued fuel performance improvement by helping manufacturers identify and correct quality program findings and deficiencies.



WORKING FROM HOME AS A VENDOR AUDITOR

There are benefits as well as pitfalls associated with working from home. Successfully working from home involves a combination of maximizing benefits and avoiding the pitfalls.

First, the benefits:

- Commute time. When not on a vendor audit, imagine working a 10-hour day with a 1-minute commute. The near zero commute time is tremendously efficient.
- Fewer distractions. When working from home, you need to have a home office. My
 office is upstairs and going there puts me in the right frame of mind for working.
 Co-workers do not interrupt me by walking into my office for casual conversation.



• Minimized travel time. I relocated to New Orleans and do not have coast-to-coast flights to vendor sites. I take an Uber to the nearby airport, which provides convenient flights to most places. The company saves money since I avoid personal car mileage and airport parking fees. Because I relocated, I do not drive late at night through hog and deer-infested, rural roads to return home.

Now the Pitfalls:

- You can become isolated from coworkers.
- Management may underutilize you since you are out of sight, out of mind.
- You may lose track of company issues, you may lose sense of the corporate culture.

To avoid these pitfalls, you need a combination of the right worker and the right management. Selecting someone who has been very engaged at the site, as opposed to someone hired from outside the company is key. A remote worker who is familiar with site processes and personnel will be much more likely to contribute from afar. I have been able to participate in internal audits, edit audit reports, and suggest process improvements precisely because I had done those duties on site. An outside hire, even if required to work onsite for a limited time, will simply have insufficient local knowledge to do more than strictly vendor auditor duties.

Leverage technology to enhance communication. I use skype quite often to participate in meetings and to keep engaged. Skype provides the visual information of a face-to-face meeting. I have my office phone forwarded to my cell phone. I also go to the site at the beginning of outages to provide Operations oversight. Such visits increase my visibility and reset my presence on site.

Takeaways: Hire an engaged site-experienced worker. Consider relocation to near a middle of the country, well-serviced airport. Managers and supervisors should use technology and keep the employee engaged in internal affairs. Bring the employee back to site to help during high tempo times such as the beginning or end of refueling outages.



2017 NUPIC VENDOR CONFERENCE - RECAP

NUPIC Vendors, Utility Members, Regulators, Industry Professionals and Representatives from INPO, NEI, and EPRI met in New Orleans, LA on June 21-22, 2017, for the year's premier networking opportunity for Oversight Professionals. The assembled participants totaled over 350, two-thirds of which were Vendor Representatives who are included in the NUPIC Audit Process. Regional Host Entergy provided a venue at the Hilton New Orleans Riverside that included an evening Mississippi Riverboat Dinner Cruise aboard the Creole Queen.

Conference participants were updated both days on the latest industry developments. The role of Nuclear Oversight in improving equipment reliability and plant performance through the construction, operation, and decommissioning life cycle was emphasized in presentations by INPO, NEI, and others. Substantive presentations on Delivering the Nuclear Promise, Cyber-Security, Dedication, Equipment Reliability, CFSI, and New Construction were also provided. Promising new technologies such as the Small Nuclear Reactor Project underway at TVA were discussed. Regulators presented current findings from vendor inspections and other observed industry trends.
